**WAC 260-32-010 Minimum requirements to obtain a jockey's license.** In order to obtain a jockey license a person must meet the following minimum requirements:

- (1) Be at least (~~eighteen~~) sixteen years of age; and
- (2) Be engaged by a trainer to ride in a race.
