A \$127 license fee cap applies to all license combinations with the exception of OWNER, VETERINARIAN, and VENDOR licenses. Class C owners must add a \$17 Labor and Industries Insurance fee. Class A owners that own total of 100% of a horse(s), must add \$150. If you own less then 100% of a horse(s) please contact the WHRC for the Labor and Industries Insurance fee owed.
